RESOLVE,

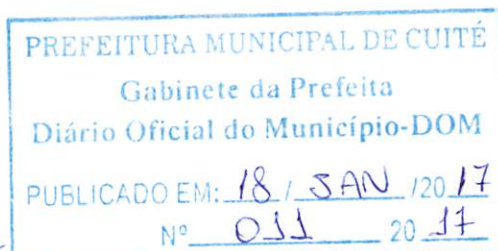
